007.2 Members considered future methods of communicating with residents, and preferred frequency of future printed media; following the withdrawal of 'On the Button' printed edition. 2 options were discussed:

- Arlesey Town Council to produce a half yearly newsletter with Council activity/editorial, advertisements and village information, for compilation and production by external company. Quotes required to establish costs. S Maddox had offered assistance.
- Arlesey Town Council produce a half yearly newsletter of one double sided A4 sheet communicating key updates on Council activity and information, to be produced in Town Council office and distributed through grounds maintenance staff and Councillors wishing to volunteer services for distribution

RECOMMENDATION

that Arlesey Town Council produce a half yearly newsletter of double sided A4 size black and white, in house, and distribute via Grounds maintenance staff and volunteering Councillors

17/008 WEBSITE REVIEW

008.1 Members considered methods of achieving Town Council website improvements. Discussion followed on ideas and research required into improvements and implementation of alterations. Formation of a Working Party consisting of Cllrs Want, Wallace, Livermore and interested Councillors not on the Public Relations Committee was suggested.

RECOMMENDATION

that Councillors Want, Wallace, Livermore and interested Councillors not on the Public Relations Committee, form a working party to discuss methods of improvement for Town Council Website. An update to be provided at Town Council meeting 18 July 2017.

008.2 Members considered correspondence received from current broadband/internet provider Cloudscape, on migration of Town Council website and email addresses from '.co.uk' to a '.gov.uk' domain name. Cllr Want felt that the quotation was appropriate for office 365 management and billing, higher than expected for domain name changes.

Standing Orders suspended: Cllr Livermore questioned benefit of '.gov.uk' email addresses as many councillors had designated email addresses specifically for council business, and if costs justified/required. **Standing Orders re-instated**

Cllr Want suggested that domain name and web hosting could fall into remit of website working party and that Cllr Auburn invited to join working party.

RECOMMENDATION

that website working party to include Cllr Auburn, explore costs involved with website domain name change to '.gov.uk', provision of councillor email addresses and management/billing of office 365.
